

## Information for authors

1. The objective of *Bioethics Complutense* Magazine is to contribute to the dissemination and development of bioethics from a plural, open and deliberative perspective. All opinions are included, provided they are justified, and the contributions of the various approaches to issues are valued.

2. *Bioethics Complutense* Magazine is published quarterly (four issues per year), in electronic form, under a Creative Commons© license Attribution- NonCommercial-NoDerivs (<http://creativecommons.org/licenses/by-nc-nd/4.0/>).

3. **Articles:** *Bioethics Complutense* Magazine publishes articles in Spanish, but accepts originals in English (see other languages). Articles should not exceed 3,500 words (including tables and charts, if any); shall be preceded by title, abstract (maximum 80 words) and keywords, both in the language in which they were written and in English.

At the end of the article may be included a References section. In this section works should be entered in alphabetical order, following the APA system of citation. Examples:

- Fins, J.J. (2010). The humanities and the future of bioethics education. *Cambridge Quarterly of Healthcare Ethics* 19, 518-21.
- Hare, R.M. (1994). Utilitarianism and deontological principles. En R. Gillon (ed.), *Principles of Health Care Ethics*. (pp.149-157). Chichester: John Wiley & Sons Ltd.
- Presidential Commission for the Study of Bioethical Issues. (Marzo 2015). Grey Matters. Topics at the Intersection of Neuroscience, Ethics and Society. If the article contains notes, they will be located as footnotes, numbered consecutively as superscript calls included in the text. The bibliographical references in the notes should follow the APA citation system.

4. **Reviews:** Book reviews, events reviews and other informations will not exceed 1,500 words. They include the title and bibliographic data of the book or the event data.

5. The inclusion of tables, charts, drawings and pictures is accepted.

6. The originals must be sent in Word format (with text as clean as possible without introducing codes) to the following email address: [bioeticacomplutense@gmail.com](mailto:bioeticacomplutense@gmail.com)

The author must specify his/her e-mail address. Also, it must be attached a brief curriculum (maximum 3 lines) and affiliation data he/she wants to include with his/her name.

7. Receipt of manuscripts will be acknowledged. The Editorial Board will decide, based on the reports of the evaluators, on the desirability of publication.

8. Manuscripts submitted must not have been published previously or be in process of publication.

9. There must be expressed the potential conflicts of interest that authors may have (financial or personal relationships that may influence their work inappropriately).
