- How can a dynamic labour market for researchers stimulate effective research and innovation?
- What are the good Nordic experiences? And what are some other good experiences that promote regional growth?

The concept of ERA (European research area) and the concept of NORIA (Nordic research and innovation area) highlight the fact that there is a need for more regional cooperation in the future. The vision for ERA is an open inner market for research and innovation. In many ways the Nordic region is interesting because the effort regarding research and innovation is one of the strongest in the world.

Today, research funds are mainly distributed nationally and all countries have their own systems for evaluation and application. Important synergy benefits could be gained by combining national efforts. The Nordic Council of Ministers has from Technopolis commissioned a study analysing the advantages and disadvantages, which an opening of national research funds could result in (this including the organisation of joint open applications in the Nordic region).

The study also examines the alternative side-effects for society when opening up the national funds for research. The findings of the report will be presented at the workshop and will be the starting point for a round table discussion in the session.

The talk from the energy field can be seen as a 'test-case' for opening up research programmes.

The Baltic Sea Initiative was launched by VINNOVA and Baltic Development Forum in 2004 to create a bottom up process for stakeholders engaged in the development of the competitiveness and growth of the Baltic Sea Region. The Secretary General of the Nordic Council of Ministers has accepted to take the lead of the BSI network for 2006.

The Baltic Sea Initiative is a forum for discussion of the challenges and possibilities for improving competitiveness in the region. Better coordination of existing initiatives and formulating joint actions in order to strengthen competitiveness and innovation in the region, are goals for the Baltic Sea Initiative.

The BSI has decided to focus on five areas in 2006. These areas are:

- Improving conditions for market driven innovation in the region

Human resources in R&D play a pivotal role in Europe's attempt to face the so-called 'European Paradox', namely that Europe is unable to sufficiently turn research results into globally competitive products. But researchers need an environment which allows them to act accordingly, thus they need a labour market where movement between academia and industry is feasible, structured and rewarded.

Such mobility is not a goal in itself, it is an instrument that can effectively contribute to foster innovation, to share and transfer knowledge and to contribute to enhance university-based technology initiatives.

Galathea 3 is the largest Danish scientific expedition for more than 50 years. The aim of the expedition is to strengthen Danish scientific research, not just by virtue of the research projects that have been included in the expedition, but also in relation to the recruitment of the coming generations of research scientists.

The foundations of Galathea3 and all the educational perspectives and dissemination of information activities surrounding the expedition consists of the total of 71 research projects that will be on board when the navy surveillance vessel *Vaedderen* (the Ram) sails around the world from August 2006 until April 2007.
