Publishing Guidelines

1. The *Revista de Filosofía* publishes original papers of outstanding scientific quality on any philosophical subject. It is aimed at practitioners of philosophy. It is published twice a year.

2. The *Revista de Filosofía* publishes articles in Spanish, German, Portuguese, French, English and Italian. Articles should not exceed 10,000 words, and must be preceded by title, abstract (maximum 80 words) and keywords in both the original language and in English. This journal does not publish book notes or reviews.

3. Include a bibliography at the end of the article. Works cited in the article should appear in the bibliography in alphabetical order using the author-year system as in the following examples:

Dennett, D. (1968): *Content and Consciousness*, Londres, Routledge.

Quine, W.V. (1967): "The nature of natural knowledge", en S. Guttenplan (ed.), *Mind and Language*, Oxford, Clarendon Press, pp. 67-81.

Rorty, R. (1972): "Indeterminacy of translation and of truth", *Synthese*, 23, pp. 443-462.

4. In the event that the article contains notes, they shall be located at the foot of the page. References in the footnotes or cited in the main text will follow the author-year system, according to the pattern shown in the bibliographical references section; however, in this case, only the surname of the author, the date of publication –in parentheses– and followed by a comma, the page number or numbers, using the abbreviations "p." or "pp."

5. Manuscripts may be sent to the following e-mail: revfilos@filos.ucm.es or postal address: "Revista de Filosofía. Facultad de Filosofía. Universidad Complutense de Madrid. 28040 Madrid". Mailed manuscripts should be submitted using DIN A4 paper, double spaced, accompanied by a CD in Word or RTF format. Since the texts are to be handled with layout software and sent to press, it is preferable to use minimal formatting.

6. For Greek language citations, observe the following rules:

i. Greek characters are reserved for annotations or philosophical discussions and short citations.

ii. In the remaining cases it should be transliterated in italics into the Latin alphabet according to the following guidelines:

a) *accents*: respect the original Greek words, e.g. *tò stoicheïon*.

b) *spirits*: the rough spirit is always transliterated with the letter h, e.g. *hodós*, *rhadinós*.

c) *long vowels*: indicate the respective diacritic, even if they have an accent, but not when there is a circumflex accent, e.g. *archê* but *archês*; *phôs*, but *phôs*; *aitíai*. (nom. pl.), but *aitíai* (dat. sing.).

d) *iota subscript*, is ascribed, e.g. *zôion*, *dikaiâi*.

e) *consonants*:

κ to k, e.g. *kalós*

ζ to z, e.g. *zygós*

χ to ch, e.g. *chrêmata*

θ to th, e.g. *theós*

υ to y, e.g. *phýsis*; in diphthongs to u, e.g., *autós*, *eudaimonía*, *ousía*.

φ to ph, e.g. *phrônêsis*

ψ to ps, e.g. *psychê*

γγ to ng, e.g. *ángelos*

γκ to nk, e.g. *anánkê*

γχ to nch, e.g. *élenchos*

γξ to nš, e.g. *sphinx*

f) All other letters are transliterated with its Latin equivalent, e.g. *idéa*, *pólis*.

g) For proper names, use the most common forms of transcription.

7. The quotations in Hebrew and Arabic will abide by the rules established by the specialists in Hebrew philosophy and Arabic philosophy.

8. The manuscripts must be presented so as to ensure anonymity during the selection process. In particular, the name and address of the author should only appear on a separate sheet. The author must indicate the full postal address of the University or Institution and the Department to which they belong, as well as an e-mail address.

9. Submitted manuscripts will receive a confirmation letter indicating the expected date of the publication assessment, but without any other correspondence. The maximum time between receipt of manuscripts and communication to the author of acceptance (or not) is eight months.

10. The evaluation of each manuscript will be provided by two external reviewers. The Editorial Board will decide, based on the respective reports, which manuscripts to publish. The Editorial Secretary will communicate the decision to the author and, if it has been accepted, the expected date of publication. If necessary, the author may be asked for a final version of the manuscript.

11. The final proof will be sent to the author that must be corrected within a maximum period of one week. During this phase, amendments to the text will not be accepted.

12. Submitted manuscripts must not have been previously published or be in the process of being published. The acceptance of a paper for publication implies that the rights of copyright, in any medium and by whatever medium, are transferred to Publishing Service of the Complutense University of Madrid, publisher of the *Revista de Filosofía*. Following its publication in the *Revista de Filosofía* authors can reproduce and reference to the place of original publication.

13. The authors of the articles will receive a complete copy of the journal.
