Part B. CV SUMMARY (*max. 3500 characters, including spaces*)

Clara García has a PhD in Economics from the UCM. She is currently Associate Professor (“Contratado Doctor”) at the “World Political Economy and Development” teaching unit, within the Applied Economics, Structure and History Department at that same university (with an accreditation from ANECA for Full Professor). Previously, she was Associate Professor at the University of Huelva; and visiting researcher at the Berkely Rountable on the International Economy at the University of California-Berkeley, the Political Economy Research Institute at the University of Massachusetts Amherst, and the Haas School of Business at the University of California-Berkeley.

She has two research periods (“sexenios”) credited by the CNEAI (2003-2008 and 2009-2014). Her lines of research are framed in issues of policies and institutions for economic growth and productive upgrading. More specifically, she has worked on technological upgrading, productive sectors, and external insertion; with a double geographical specialization, having done empirical work on East Asia, and China in particular, and more recently on the economy of Spain. On these issues he has published more than thirty articles and book chapters and six specialized books; and has presented more than twenty communications and invited papers in specialized congresses, the vast majority of international character. In particular, she has publications in international journals indexed in the Journal of Citation Reports (JCR), such as Cambridge Journal of Economics, Asia-Pacific Viewpoint, Energy Policy, Governance, Post-Communist Economies or The Developing Economies; as well as in Spanish journals also indexed in JCR and of recognized quality, such as Revista de Historia Industrial or Revista de Economía Mundial. She has also published books and book chapters in editorials such as Akal, Ariel or Fundamentos.

She has participated in several competitive research projects, most of them on energy policies and institutions, or on foreign direct investment and transnational companies. She

has also done research work through contracts with the Secretary of State for International Cooperation. And she has directed three doctoral theses, one on institutions for productive development, another on functional distribution and economic growth, and another on external insertion and foreign direct investment (all of them with an empirical focus in China). She teaches regularly on applied macroeconomics, world economy, Spanish economy and East Asian economies (and China in particular), both at the UCM and in official degrees and expert courses from other universities (Instituto de Empresa University and Universidad Pontificia de Comillas, among others).

Finally, in terms of academic management positions, she is member of the Academic Committee of the UCM Economics Ph.D program (since 2016). And was Vice Dean of Quality Assessment and Bachelor's Degrees (between 2014 and 2016); Coordinator of the Economics Bachelor's Degree (between 2011 and 2014); and Academic Secretary of the Master's degree in International Economics and Development (between 2005 and 2008); all within the School of Economics and Business Administration of the UCM.
