Recent research

Academic research on issues related to foreign immigration in Spain and Europe, such as border control and integration policies, social practices in interethnic relations, and public discourse and philosophies of integration. Survey design and analysis on public opinion in Spain on

immigration and the limits of tolerance. Special attention to the social situation and attitudes of Muslim immigrants in Europe, international comparison of public policies towards Islamic religious practice and teaching, and qualitative research on how the consequences of migration are perceived by members of the social networks of irregular migrants in Morocco.
