BA in Philosophy (1996), BA in Classical Philology (2012), PhD in Philosophy (2000) and PhD in Sciences of Religion (2018) from the Complutense University of Madrid. From 2000 I teach at the Faculty of Philosophy (UCM). Since April 2019 as **Associate Professor (accredited to Full Professor** by the ANECA). I am member of the PARTyGEN (Teaching Network Participatiuon and Gender) national network for the inclusion of gender perspective in teaching. My main lines of research are social philosophy, women studies and cultural history. With a Kant-related background, my current research tackles issues as social precarity, vulnerability, poverty, oppression and social exclusion, casting light on the historical transformations of these topics and highlighting the role of intellectual women as cultural actors. My writings appeared in publishing houses as Routledge, Palgrave McMillan, Walter de Gruyter, Duncker & Humblot, Franz Steiner, Lexington Books, Brill, Comares, Tecnos and Alianza. I have **52 publications in Scopus** (4 h-index) and 49 citations. 2 six-years acknowledgments of research (CNEAI 2007-2013; 2013-2018). I am an external member of the INSTIFEM (UCM), CFUL (Portugal) and the IF of the Univ. of Porto.
