



## NOMINATION AND APPLICATION PROCEDURE FOR EXCHANGE STUDENTS MOBILITY (non Erasmus):

### Length of the semester at the UCM:

- ❖ **1st Semester** (Fall Semester): September 2026 – January 2027
- ❖ **2nd Semester** (Spring Semester): January – June 2027

### **STEP 1: Students Nomination**

The students need to be officially nominated by their home University. The nomination will be done by sending an email to [conveniosin@rect.ucm.es](mailto:conveniosin@rect.ucm.es) with the following data:

### **STEP 2: Online Application (MoveOn Platform)**

In order to complete the acceptance process, all nominated students must fill in the UCM online application. Please follow the instructions below:

### 1. Access to Move-On (Mozilla Firefox recommended):

- All sections should be completed
- You have the option to complete and save your application in multiple sessions.

### 2. You must upload the following documents to complete your application:

- ✓ CV
- ✓ Valid Passport
- ✓ Spanish language certificate. You can check the language requirements here: <https://www.ucm.es/language-requirements>.
- ✓ If your native tongue is Spanish, there is no need to provide us with a language certificate, you can put C1.
- ✓ Transcript of Records
- ✓ Learning Agreement with the courses you would like to follow at UCM: <https://www.ucm.es/file/ra>.

### 3. DEADLINES (<https://www.ucm.es/plazos-deadlines-convenios>):

#### a. First Semester/ Fall Semester (September 2026 – January 2027):

- **Nomination: February 15th - April 15th**
- **Application: March 1st - April 30th**

#### b. Second Semester/Spring Semester (January 2027 – June 2027):

- **Nomination: September 1st - November 15th**
- **Application: September 15th - November 30th**

### **CLARIFICATION:**

In Europe, courses are set under the **ECTS (European Credit Transfer and Accumulation System)**. Most of the semestral courses are set under **6 ECTS** but it will be usual to find some exceptions depending on each degree.

*Here is an example for the Law Undergraduate program on how to see and select subjects (list of degrees on the In Europe courses are under the ECTS (European Credit Transfer and Accumulation System).)*

Subjects

As shown in the table, subjects are taught under a determined period, either in the first semester or in the second semester.

Given this, if a student wants, for example, to take **Derecho Penal I**, they will only be able to come during the first semester.

**IMPORTANT:**

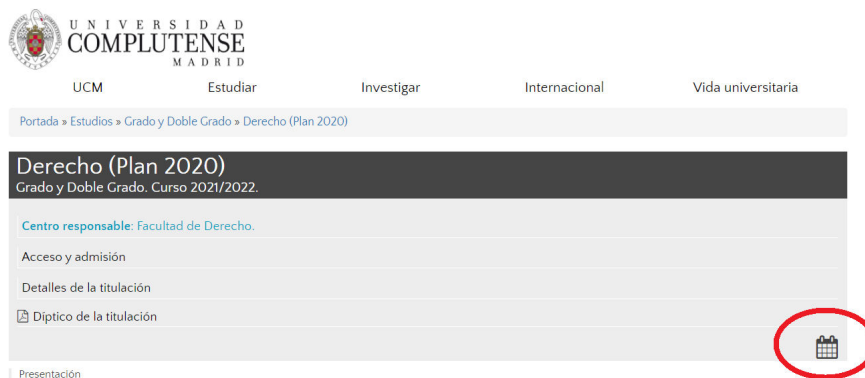
Students can NOT apply to:

- Subjects of the first year of the undergraduate programs.
- Subjects given on graduate programs facilitating the entrance in professional regulated areas.
- Master's courses if they are not graduates of their home universities.
- **PhD students should send a work plan in order to apply for a tutor.**

Before you choose your courses, please check the corresponding schedules because they may overlap if subjects are from different years or faculties.

You have to possibility to follow courses from different degrees or faculties as long as you respect the following conditions:

**1. You can NOT enroll in:**

- Subjects of the first year of the undergraduate programs.
- Subjects given on graduate programs facilitating the entrance in professional regulated areas.
- End-of-degree and end-of-master's work subjects.
- Master's subjects if you have not completed your master's degree at your home university.
- Faculty of Odontology: consult course offer at <https://www.ucm.es/condiciones-facultad-de-odontologia>

**2. A B1 level in Spanish is mandatory**

- For **Philology, Geography, History and Communications Sciences studies**, a higher language knowledge is required (**DELE o B2 SIELE**).
- For Masters and Doctorate, it is highly recommended a C1 Spanish level, since courses or investigation programs in other languages cannot be guaranteed.

**3. Number of credits you can choose without any additional cost\*:**

- Between 12 y 30 ECTS per semester for **undergraduate** programs.
- Between 12 y 18 ECTS per semester for **graduate** programs.

**4. Please take into account specific conditions depending on the faculties:** <https://www.ucm.es/limites-y-condiciones-visitantes>.

**IMPORTANT:**

- If the exchange mobility is programmed for one semester, annual subjects cannot be taken
- Students that are studying an undergraduate program are not able to choose subjects from graduate levels.
- The registration of subjects will be free (maximum 30 ECTS credits for undergraduate studies and 18 ECTS credits for graduate studies), although there is a possibility to pay an administrative fee that could be a maximum of 100€ and that would be paid, where appropriate, when the registration is formalized.

It is important to provide us with the following data in order to identify you:

- Name, email, Home University, period of stay, UCM faculty where you will be studying.

#### **DO NOT FORGET TO DO EVERYTHING WITHIN THE DEADLINE:**

**a. First Semester/ Fall Semester** (September 2026 – January 2027):

- > **Nomination: February 15th - April 15th**
- > **Application: March 1st - April 30th**

**b. Second Semester/Spring Semester** (January 2027 – June 2027):

- > **Nomination: September 1st - November 15th**
- > **Application: September 15th - November 30th**

Once acceptance has been obtained from the Faculty (or Faculties), we will send the acceptance letter by email from the UCM to the Mobility Office of the home university and to the student.

**(\* It is recommended to book flight tickets and to contract your international medical insurance (covering the entire period of the exchange) only after having received this letter.**

#### **Once you arrive in Madrid...**

We will have a welcome meeting. We will inform you about the date and time in the acceptance letter. The meeting will be held at Salón de Actos del Edificio de Estudiantes de la UCM. It is located in the Student Office building in calle Avenida Complutense, s/n 28040 Madrid. At the meeting, we will give information on how and where to register your courses.

If you have any doubts about the classrooms or the timetables of the subjects you have chosen, you should ask at your Faculty (<https://www.ucm.es/ola>).
