RESUMEN DEL CURSO

Desde la Revolución Francesa hasta el fin de la Guerra Fría, los nacionalismos han sido un elemento fundamental de la política y la cultura europea. El curso analiza el surgimiento y desarrollo del nacionalismo liberal a principios del siglo XIX, la creación de los Estados-nación alemán e italiano y las tensiones étnicas en los imperios de la Europa central y oriental. El curso también estudia las complejas relaciones entre clase e identidad nacional; la nacionalización de las masas, y las conexiones entre fascismo y nacionalismo en el periodo de entreguerras. Por último, se analiza las transformaciones de los nacionalismos y las identidades nacionales en la Europa dividida de la Guerra Fría.
