

ERASMUS+ CON PAÍSES ASOCIADOS (KA107) – PROYECTOS UCM

INFORMACIÓN GENERAL

El Programa Erasmus+ ofrece desde 2014 nuevas posibilidades de movilidad con universidades de países asociados, definidos como todos aquellos países distintos de los 27 países miembros de la UE; países de la AELC (asociación Europea de Libre Comercio) y el EEE (Espacio Económico Europeo): Islandia, Liechtenstein y Noruega y países candidatos a la adhesión: Turquía y Antigua República Yugoslava de Macedonia.
