**Part B. CV SUMMARY**

The academic and professional career can be organized in three stages: i) Pre-doctorate research period: Training Research Personnel Fellowship (FPI) of the Community of Madrid (1998-2002) and hired by the private company Public Administration Consultants (2003-2006); ii) Post-doctorate research period: "I3P" programme at CSIC (2006-2009) and researcher of "Ramón y Cajal programme (I3)" of Ministry of Economy and Competitiveness (2010-2017); iii) Associate Professor at the Complutense University of Madrid (2017-present). He has been Deputy Director of the Department of Geography at this university. His research interests have evolved from studies on industrial location to regional/urban development, the knowledge economy, innovation, employment and urban policy. He has participated continuously in nine projects of the National Plan and three international projects. Currently he is Principal Investigator of the project "Economic, social and political innovation in Madrid in the context of the (post) pandemic: strategies and territorial dimensions" (National R+D programme), as well research grant holder of Regional Studies Association (MeRSA, 2020). He has been a full member of the Management Committee of the COST Action "Cities: Regrowing Smaller: Fostering Knowledge on Regeneration Strategies in Shrinking Cities across Europe" (2009-2013). It also highlights the participation in contracts for DG REGIO-European Commission and the coordination of contracts for the



Madrid City Council. His curriculum includes more than 60 scientific publications, highlighting many contributions in top international journals, such as *Cities*, *Papers in Regional Science*, *Environment and Planning A*, *Environment and Planning C*, *Urban Geography*, *European Urban and Regional Studies* or *Regional Studies*. Among the books, individual and co-authored works in publishers such as Edward Elgar, Springer-Verlag or Roudledge-Earthscan stand out. He periodically participates in national and international congresses. He has recently been invited within the program “RECITY ITN: Reviving contracting cities - innovative paths and perspectives towards habitability for contracting cities in Europe” (2019-2022) (Marie-Sklódowska-Curie Actions, Horizon 2020). He has carried out research stays in international centers (University of California, London School of Economics, Loughborough University, Amsterdam University, Lisbon University). He is member of international research networks such as Global and World Cities Study Group or Shrinking Cities International Research Network, as well as member of the UCM- 940614 Research Group “Territory, Development and Culture”.
