Abstract: Sustainable Development Goals (SDGs) are the 2030 Agenda for Sustainable Development approved in 2015 by the United Nations (UN) as a set of political decisions currently being made. Through this Agenda, countries commit to doing better overall in 17 goals, 169 targets and 232 indicators related to the UN's common goal of better humanity. Paired to the creation of global indicators by the UN, a central statistical (SD) indicator (time report on compliance with the UN) is developed for the European Union to monitor the development with respect to the UN's Agenda. In this report, we analyze the compliance with the UN's Agenda and the indicators of the European Union context, with respect to these indicators, also analyzing the convergence of divergence among EU countries along the time, and highlighting specific issues for each goal, being starting information on the indicators of compliance with the UN's Agenda. The data is complemented with some comparative data that gives an overview of the relative compliance of each country in the EU region.

According to the Millennium Development Goals, the 2009 Agenda for Sustainable Development approved in 2015 by the United Nations constituted a successful example of how international political agreements around global indicators in the medium and long term can be institutionalized in a 64-countries and quantitative objectives (UN, 2015, 2017a, 2017b). Specifically, the UN's Agenda for Sustainable Development Goals (SDG) were used through 232 indicators, covering issues as relevant and diverse as gender equality, reduction of poverty and inequality and environmental sustainability. Paired to the creation of these global indicators by the UN, a central statistical indicator (time report on compliance with the UN) is developed for the European Union to monitor the development with respect to the UN's Agenda. These European indicators serve to reflect the situation in each country in such as the dimensions that comprise the 2030 Agenda: poverty indicators, health and hunger indicators, employment indicators, climate action indicators, and more others.


