SUBJECT TITLE: Introduction to Comparative Politics in Europe

COMPETENCES- OBJECTIVES (BRIEF DESCRIPTION): A historical and comparative study of the most representative political, administrative, and economic models of Europe in the 20th and 21st centuries. The course is divided into two parts: An introduction to comparative politics applied to Europe. Then, a specific analysis of the political systems in Germany, France, Italy, the United Kingdom, and the government of the European Union, and Spain as a political model that since 1931 has experienced the existence or coexistence of three different political systems: The Republic, dictatorship, and constitutional monarchy.

This course aims to provide the student with an overview of different political systems within the European Union and provide the necessary theoretical tools to make a comparative analysis of these systems with the political model of the United States of America.

TEACHING METHODOLOGY

This course is structured in two parts and ten themes. The first part deals with an introduction to comparative politics and the comparative method. It also includes a broad perspective of the transformation of European politics in the XX and XXI century and presents the comparative debates between types of democracies (consensual and majoritarian) and political systems (presidential, semi-presidential and parliamentarian). With this background, Part 2 is centered in case studies, where the main Western European countries will be analyzed through the lens of comparative politics. This includes an introduction to the European Union as a political system and a more in-depth analysis of the Spanish political system. The course ends with a final discussion on current trends in Europe and a special focus on democratic backsliding, which helps to compare with the US case.

Methodologically, the course includes an initial presentation by the professor on each theme. Students are expected to read the compulsory material for class discussions. Different assignments will be organized for analyzing different features of European political systems using specific databases (but no knowledge of statistics is expected nor needed for the assignments). The readings and data used in class will be available at the Campus Virtual.

Participation in the debates and presentations are also part of the course.

SUBJECT OBJECTIVES

- 1. To become familiar with the idea and logic of the comparative politics.
- 2. To distinguish between the main types of democracies and political systems, with a specific focus on Western Europe.
- 3. To become familiar with specific issues, including government formation, the different types of parliaments, parties, and party systems in Europe.
- 4. To have a more in-depth and applied knowledge of the political systems of the main Western European countries and the European Union.
- 5. To become familiar with different datasets that explore public opinion, party positioning and government formation in Europe.
- 6. To develop analytical skills for comparing political systems in Europe and the US.
